#### 6. Submission of Audited Financial Statements for 2013-2014

The Federation treasurer, Lyne Sauvageau, presents her report. She happily notes that, for the second year in a row, the Federation is able to present a modest surplus.

She notes three major events that have marked the past fiscal year:

- In consultation and with the approval of the Board of Directors, the Federation changed its fiscal year from an October 1 to September 30 period to a January 1 to December 31 period. This change was done to allow the Federation to respond to and/or communicate the impact of major financial activities and to take advantage of opportunities as they arise. As a result, the financial statements presented to you are for a 15 month period starting October 1, 2012 and ending December 31, 2013.
- To further simplify presentation and internal accounting processes and under the advice of the Federations Auditors, the Federation no longer prescribes to the Fund Accounting methodology to record and present financial information. Funds are now identified as Unrestricted or Internally Restricted.





• Finally the Federation complied with the mandatory changes to the Accounting Framework as prescribed by the CICA governing body.

She closes by thanking the Federation's Secretariat for the hard work in this particularly challenging financial year due to the many changes.

#### 8. Report of the Nominating Committee

Graham Carr, the Federation's Past-President and Chair of the Nominating Committee, reports that the nomination committee has recruited Stephen J. Toope, President and Vice-Chancellor of the University of British Columbian and Cindy Blackstock of the University of Alberta to run respectively for President and Director, Equity and Diversity of the Board of the Directors. He also notes that two incumbent Board members, Doug Peers and Fernand Gervais, had decided to seek reelection for their positions as their terms were coming to an end. Following online elections that closed on March 4, 2014, all four candidates supported by the nominating committee were declared elected.

Gayle MacDonald, Director, Institutions, gives an update on institutional membership. She also invites members to highlight institutions that could be potential members and invites members to reflect on how smaller institutions, who can't host Congress can still host Federation activities on their campuses.

#### **10. Update on Strategic Framework**

Jean-Marc Mangin, Executive Director, updates members on the 2011-2016 Strategic Framework and notes that the Board of Directors will start working on renewing this Framework for the next period starting tomorrow.

Frederic Bouchard of the Canadian Philosophical Association asks what place the declining confidence in the Federation's advocacy by some members will have in the new Framework. Jean-Marc notes that the Federation has done some great work in terms of advocacy, particularly in the Federal Budget 2015. The new framework will need to define its goals in terms of advocacy by building on the achievements of the current plan. Jean-Marc reminded members about the advocacy principles adopted by the Board and available on the Federation's website, which focuses on areas of commonality amongst all of its diverse membership. He also mentions that, as a Federation, members retain their individual autonomy and voice.

Victor Glickman, of the Canadian Society for the Study of Education, notes that the Federation needs to develop better accountability tools to address members' frustrations regarding Congress and this should be reflected upon in the new Framework.

#### 11. Policy Outreach by the Federation: Issues and Challenges

Antonia invites members of the Board of Directors to update the General Assembly on their respective policy portfolios.

Lisa Philips, Director, Research Policy notes three important projects on which she has been working in the past year: the Research Impact measurement project, the changes in Mitacs internship eligibility criteria, and hosting the Canada Prizes ceremony at York University on May 7.

Fernand Gervais, Director, Teaching and Learning notes again three important files on which he has been working during his past term: he is organizing the Congress for The International Society for the Scholarship of Teaching & Learning (ISSOTL) at Université Laval in October 2014, in which the Federation will be a partner, he is currently studying the possibility of putting together strategic information bulletin on teaching and learning to be shared with members and finally, he notes that he wished to continue connecting members with each other to facilitate joint initiatives.





Doug Peers, Director, Development notes that the Federation is progressing in a context of a change of culture in philanthropy and has to develop better methods to reach potential donors and philanthropists.

#### 12. Report on Awards to Scholarly Publications Program

Anne-Marie Fortier, Chair of the ASPP's Academic Council, notes three major changes to the program in the past year that are meant to help boost its profile. Firstly, the Academic Council has reviewed the program's assessment system as of 1 April, 2013. One more significant development this year was the beginning of an outreach strategy with Francophone publishers. Finally, the Open Access policy for the ASPP has been launched. An international policy scan has been completed and a draft policy is being prepared for consultation.

#### 13. Congress Update (2014 to 2018)

Due to lack of time, Jean-Marc Mangin, Executive Director, is unable to give a full update on upcoming Congresses. However, he extends the invitation to all members to attend the Congress at Brock in May 2014.

#### 14. Summary and Adjournment

The President, Antonia Maioni, declares the meeting adjourned at 1:36pm.

# Stephen J. Toope, PhD

Director, Munk School of Global Affairs, University of Toronto

#### President

Stephen J. Toope is currently the Director of the Munk School of Global Affairs at the University of Toronto since January 2015. He was President and Vice-Chancellor, the University of British Columbia, from 2006-14. A former President of the Pierre Elliott Trudeau Foundation, and Dean of Law, McGill University, Professor Toope also served as Law Clerk to the Rt. Hon. Brian Dickson, of the Supreme Court of Canada. He served as



President of the Canadian Council on International Law and member of the Executive Council of the American Society of International Law. Toope publishes in leading international journals on international dispute resolution, international environmental law, human rights, the use of force, and international legal theory. Toope also served as Chair of the United Nations Working Group on Enforced and Involuntary Disappearances.

His most recent book with Jutta Brunnée, <u>Legitimacy and Legality in International Law: An</u> <u>Interactional Account</u>. Cambridge: Cambridge University Press (2010) was winner of the American Society of International Law's 2011 Certificate of Merit for Creative Scholarship.





# Antonia Maioni, PhD

Professor, Department of Political Science/Institute for Health and Social Policy, McGill University

#### President

Antonia Maioni is Professor of Political Science at McGill University in the Department of Political Science and the Institute of Health and Social Policy. From 2001 to 2011, she served as



the Director of Interdisciplinary McGill Institute for the Study of Canada, while holding the position of William Dawson Scholar at McGill University.

Trained as a political scientist, Professor Maioni studied at St. Mary's University, earned a B.A. in Political Science and French at Université Laval, an M.A. from Carleton University's Norman Paterson School of International Affairs, and a Ph.D. in Political Science from Northwestern University.

She has held visiting appointments at Harvard's Center for European Studies, the North American Studies Program at Duke University, and the European University Institute in Fiesole, Italy, as well as teaching at the Mailman School of Public Health at Columbia University. At McGill University, she teaches in the Department of Political Science and in the Fundamentals of Medicine and Dentistry, and is a member of the International Masters in Health Leadership team in the Desautels Faculty of Management.

Professor Maioni has published widely in the fields of Canadian and comparative politics, with a particular focus on public policy, social policy and health care reform. A recipient of many research grants, her most recent research projects were funded by the Social Sciences and Humanities Research Council of Canada, the Canadian Institutes for Health Research, and the Max Bell Foundation. Her latest book, *Health Care in Canada*, was published by Oxford University Press (Canada) in 2014. In addition, she contributes to the research community as a peer reviewer for CHIR and as a member of CIFAR's Research Council.

In addition to teaching and scholarship, she is active in the wider academic and public community, having organized numerous workshops, roundtables and conferences on issues of public policy at McGill University, as well as participating regularly in academic and policy settings in Canada, the US and abroad. She is also a frequent media commentator on Canadian and Quebec politics and public policy, in both English and French, is a regular political analyst for the CTV News and a contributor to the Globe and Mail.

Antonia Maioni has served on the boards of the Institute for Research on Public Policy, the Banff Forum, the Canadian Health Services Research Foundation, the McCord Museum of Canadian History, the Priory School of Montreal, as well as serving as a mentor for the Action Canada leadership program and the Loran Scholars/Canadian Merit Scholarships. She is currently on the Board of the Jeanne Sauvé Scholars Program and the Sacred Heart School of Montreal.





# **Carmen Charette**

#### Vice-president, External Relations, University of Victoria

#### Treasurer

Carmen Charette was appointed vice-president external relations at the University of Victoria in August 2012. The relations portfolio includes alumni relations, external government relations, communications fundraising, and marketing, community relations, corporate relations, ceremonies and events, the Farguhar Auditorium and the Legacy Art Galleries.



Carmen was previously executive vice-president of the Social Sciences and Humanities Research Council (SSHRC). Prior to joining SSHRC in 2007, Carmen was director-general with the Science and Innovation Sector of Industry Canada, senior vice-president with the Canada Foundation for Innovation and director with the Natural Sciences and Engineering Research Council.

In June 2014, Carmen was awarded the national <u>Walter Hitschfeld Award</u> from the Canadian Association of University Research Administrators. The award is presented to "an individual who has demonstrated an exceptional impact on the enhancement of the research environment in Canada". Carmen holds degrees in Biochemistry and in Business Administration from the University of Ottawa.





# Anne-Marie Fortier, PhD

Professor, Département des littératures, Université Laval

#### **Chair, ASPP Academic Council**

Since 1997 Anne-Marie Fortier is Professor of 19th- and 20th-Century French and Québécois Poetry in the Department of Literature, Université Laval (Québec)



Having graduated from McGill University (Ph. D. ) in French literature, she has worked on Rimbaud and René (René Char et la métaphore Rimbaud, Presses de l'Université de Montréal, 1999).

She is the Director of the *Études Littéraires* Journal and currently works on two Research Projects: the *Éloi de Grandmont* collection, which is currently in the process of being transferred to the Library and National Archives of Québec (BAnQ) and the *André Roche* collection (private) which led to a conference at London on April 2013.

Dr. Fortier has published book chapters and articles in the field of French and Quebecoise Literature in particular on magazines such as *Liberté*, *L'Atelier du roman* (Paris), Littératures McGill, *Romanic Review* (New York), *Les Lettres romanes* (Louvain, Belgium).

In addition to teaching and research, she has served as jury member for the *André Laurendeau 2014* award (ACFAS). Furthermore, because of her interest in proving the worthiness of humanities and their contributions to society, she has been appointed Chair of the Academic Council of the Awards to Scholarly Publications Program (ASPP).





# **Cindy Blackstock, PhD**

**Executive Director, First Nations Child and Family Caring Society of Canada and Associate Professor, University of Alberta** 

#### **Director, Equity and Diversity**

A member of the Gitksan First Nation, Cindy has 25 years of social work experience in child protection and indigenous children's rights. As Director of the First Nations Children's Action Research and Education Service (FNCARES) at the University of Alberta, her research interests are indigenous theory and the identification and remediation of structural inequalities affecting First Nations children, youth and families.



Her promotion of culturally-based and evidence informed solutions, has been recognized by the Nobel Women's Initiative, the Aboriginal Achievement Foundation, Frontline Defenders and many others.

An author of over 50 publications and a widely sought after public speaker, Cindy has collaborated with other Indigenous leaders to assist the United Nations Committee on the Rights of the Child in the development and adoption of a General Comment on the Rights of Indigenous children. She also recently worked with Indigenous young people, UNICEF and the United Nations Permanent Forum on Indigenous Issues to produce a youth friendly version of the United Nations Declaration on the Rights of the Child.

Cindy is currently completing a Master of Jurisprudence in Children's Law and Policy at the Loyola University Chicago.





# Dominique Marshall, PhD

**Professor and Chair, Department of History, Carleton University** 

#### **Director, Associations**

Dominique Marshall is the History Department Chair at Carleton University. She teaches Canadian and Quebec history of poverty and welfare, families and childhood, state formation, as well as the transnational



history of humanitarian aid, and Political Economy. She has written about the history of the Canadian welfare state, the history of children's rights, and the Child Welfare Committee of the League of Nations. Her current research is about the Conference on the African Child of 1931, and the early history of OXFAM in Canada.

She has been Supervisor of Graduate Studies of her department for four years, and the French Editor of the Journal of the Canadian Historical Association for 20 years. She was trained mainly at the Université de Montréal, with stays at Boston University, the London School of Economics, and SOAS. Her book, *Aux origines sociales de l'État providence* (1998) (available in English as The Social Origins of the Welfare State (2006)) received the Jean-Charles Falardeau Price from the HSSFC.





## **Doug Peers**

#### Dean, Faculty of Arts, University of Waterloo

#### **Director, Development**

Douglas Peers joined the University of Waterloo on 1 July 2011 as Dean of Arts and Professor of History. He was previously Dean of Faculty of Graduate Studies and Associate Vice-President Graduate at York University from 2007 to 2011. In 2009 he was elected president of the Canadian Association for Graduate Studies.Prior to coming to Ontario, he spent twenty years at the University of Calgary where he was Professor of



History and Associate Dean and Interim Dean of the Faculty of Social Sciences. In 2004, he was Interim Vice-President (Programs) of the Social Sciences and Humanities Research Council of Canada. He has sat on a number of boards including the management board of Aid to Scholarly Publications Program of the Canadian Federation for the Humanities and Social Sciences from 2005 to 2012 and the Board of Directors of the Shastri Indo-Canadian Institute from 1996 to 2005. In 1993 he was elected a Fellow of the Royal Historical Society.

The author of two books and co-editor of three collections, Doug has published more than twenty articles and chapters on the intellectual, political, medical and cultural dimensions of 19th century India, with a particular interest in the impact that the military had upon the character of colonial rule. He is currently co-editing India and the British Empire, a companion volume in the Oxford History of the British Empire Series.





# Fernand Gervais, PhD

#### Dean, Faculty of Education, Université Laval

#### **Director, Teaching and Learning**

Fernand Gervais is currently the Dean of the Faculty of Education at Université Laval and also a Professor in Educational Psychology at the Faculty of Education since 1994. He teaches courses in learning and cognition and his main research interests are in social cognition, situated learning and networked communities of practice. His numerous involvements related to teaching and learning include Vice-President and President of the Canadian Society for the Study of Education between 2008 and 2013 and



scientific expert for the Agence universitaire de la Francophonie (AUF) between 2002 and 2006.





# Julia Wright, PhD

#### **Professor, Department of English, Dalhousie University**

#### **Director, Associations**

I completed my Ph.D. in English Literature at the University of Western Ontario in 1994, and I am now a Full Professor in the Department of English (cross-appointed to European Studies) and Associate Dean Research in the Faculty of Arts and Social Sciences at Dalhousie University. Previously, I



was a tier-2 Canada Research Chair in English and Cultural Studies (Wilfrid Laurier University, 2002-2005) and a tier-2 Canada Research Chair in European Studies (Dalhousie, 2005-2012). Before 2002, I was an Associate Professor at the University of Waterloo. I have a reading knowledge of English and French (some Italian, a little Irish), though I miss the opportunity to speak French as often as I did when I lived in Montreal.

I have been Dalhousie's SSHRC Leader since 2013, attending meetings of that group as well as acting in that capacity at Dalhousie, for instance in organizing Connecting Cultures, a SSHRCfunded knowledge-mobilization event that included researchers from six different Faculties related to the Imagining Canada's Future initiative. I have been a Senator at two universities, and served on the Senate Executive at Wilfrid Laurier. I am something of a "policy nerd," as the phrase goes. I chaired the committee to revise Dalhousie's Scholarly Misconduct Policy to align with Tri-Council requirements, and have worked on policies at a range of other levels, including curricula for new undergraduate programs. I have served on a number of SSHRC committees, as well as on international bodies. For instance, I was on the organizing committee for a joint Canada-UK conference held near London, England (1998) and recently completed a five-year term on a Modern Language Association (MLA) Discussion Group Executive Committee (I was Chair from 2013-14). I also sit on various editorial boards in Canada, the US, and the UK, and have served on the Executives of the North American Society for the Study of Romanticism and the Canadian Association for Irish Studies (CAIS). I have also been a member of a number of conference committees dating back to the early 1990s, and have organized a series of exchanges between Dalhousie and the Sorbonne (Paris 3).

My research primarily involves ideas of nationalism and other theories of political sovereignty in eighteenth- and nineteenth-century British and Irish literature, and I am currently working on





the Irish poet Thomas Moore and Romantic-era Irish literary theory in this context. I have authored, edited, or co-edited fourteen volumes, including three monographs (my fourth is in press): *Blake, Nationalism, and the Politics of Alienation* (Ohio UP, 2004); *Ireland, India and Nationalism in Nineteenth-Century Literature* (Cambridge UP, 2007); *Representing the National Landscape in Irish Romanticism* (Syracuse UP, 2014). Among the books I have edited is the two-volume *Companion to Irish Literature* (2012), with 58 contributors from half-a-dozen countries. I also have an ongoing research interest in governance and university culture (arising from my work on the debate over Irish sovereignty during British rule), with published essays on that subject throughout my career. I have presented plenaries in Ireland, England, Canada, and the US.

I have organized panels and/or presented papers at fourteen Congresses since 1995, attending mostly ACCUTE but also other organizations such as CAIS (when it was affiliated), CSRS, and so on. I am currently on the committee organizing the inaugural Digital Humanities Summer Institute at Dalhousie, working with the Federation association the Canadian Society for Digital Humanities as well as colleagues from the DHSI at the University of Victoria. I was also my department's "campus representative" for ACCUTE for a number of years until the office moved to Dalhousie in 2014.





# Lisa Philipps, LL.M.

#### Professor, Osgoode Hall Law School, York University

#### **Director, Research Policy**

Lisa Philipps is a Professor at York University's Osgoode Hall Law School where she has been a member of the full-time faculty since 1996. Lisa teaches and writes on taxation law and fiscal policy. She has served in leadership positions at the Law School and University level, most recently as Associate Vice-President Research from 2011-2014. She currently serves as Director of Research Policy on the Board of the Federation for Humanities and Social Sciences (since 2013).



Philipps received her LL.B. from the University of Toronto ('86) and her LL.M. from York University ('92). She articled and then practiced tax law with the firm of Blake, Cassels & Graydon LLP before commencing her academic career as a full-time member of the Faculty of Law at the University of Victoria in 1991. Lisa was honoured to receive a Master Teacher Award at the University of Victoria in 1993 and a Teaching Excellence Award at Osgoode in 2005. She was featured in the Ontario Council of University Faculty Associations' video campaign, "We Ontario". Lisa is a leading socio-legal scholar in the fields of tax law, fiscal policy, and feminist legal studies (full CV and SSRN can accessed papers be here: http://www.osgoode.yorku.ca/faculty/full-time/lisa-philipps). Her research has been funded by SSHRC, the Canadian Tax Foundation, the Law Commission of Canada and others. She has published widely on topics such as income splitting, tax expenditures, R&D tax credits, balanced budget and fiscal transparency laws, gender budgeting, the distributional impact of tax cuts, taxation of family businesses, the tax treatment of disability, charitable donation tax incentives, and tax implications of unpaid work.

Philipps is a regular media commentator on tax policy issues and has spoken and provided her expertise to parliamentary committees (Finance, Status of Women), NGOs, public agencies, and law firms. A short clip of her speaking to a public audience on tax policy can be found here:

Lisa Young is Vice Provost and Dean of Graduate studies of the University of Calgary while having previously served as Associate Dean of Graduate Studies and Graduate Program Director for the department of Political Sciences.



Dr. Young has served as a board member for the Canada Association of Graduate Studies from 2012 to 2014. While being involved with the Canadian Political Association, Dr. Young has served as a jury member for the Jill Vickers Prize in 2009-2010 and has been a member of the Program Committee in 2004-2005 and chaired the committee in 2006-2007. Dr. Michael Owen is currently the Vice-President Research, Innovation & International at the University of Ontario Technology Institute. He has previously served as UOIT's Associate Provost Research and OCAD's Associate Provost Research and VP Research & Graduate Studies. Dr. Owen has also served as Associate VP Research & International at Brock



University and as Director, Research Services at Brock University, Ryserson University and the University of Saskatchewan.

Dr. Owen currently serves as the Director, Associations to the Federation for the Humanities and Social Sciences where he previously served as VP Research Dissemination and Chair, Standing Committee on Ethics and Integrity. He has served as a Board member and President of the Society of Research Administrators International and has chaired the Scholarly Symposium and the Senior Leadership Institute. He is currently a member of the International Network of Research Management Societies and a previous president of the Canadian Society of Church History. He has served as a board member for the Canadian Society for Studies in Education and the Canadian Corporation for Studies in Religion. Dr. Owen has been a board member and member of the Annual Conference Planning Committee of the Canadian Association of University Research Administrators and a board member and executive member to the National Council on Ethics in Human Research. He is currently a Board member of SHARCNet, the Southern Ontario Water Consortium, the Southern Ontario Smart Computing Innovation Platform, Ontario Council on University Research, the Durham Strategic Energy Alliance, IDEAHUB and the Clinical Trials Stakeholders Association (Ontario)/Clinical Trials Ontario. Dr. Owen is fluent in English.





# **Michael Sinatra, PhD**

#### Associate Professor of English, Université de Montréal

#### **Director, Research Dissemination**

After earning a D.Phil. at Oxford and a period as Research Associate at the Northrop Frye Centre, University of Toronto, Sinatra joined the Université de Montréal in June 2001. His work on new forms of research dissemination began



while a graduate student when he founded in February 1996 the first open access electronic journal devoted to British Romantic literature (*Romanticism and Victorianism on the Net*), which expanded into the Victorian period in 2007 and is funded by SSHRC. His interest in the impact of technologies on knowledge transfer in the social sciences and humanities led to his leading the CFI-funded project *Synergies: The Canadian Information Network for Research in the Social Sciences and Humanities*, between 2007 and 2012, which involved 22 universities and over 40 researchers from coast to coast.

Sinatra was one of the researchers involved in three SSHRC-funded Knowledge Synthesis on the Digital Economy consultation: "Lasting Change: Sustaining Digital Scholarship and Culture in Canada" (Brown, *et al.*), "Digital Technology Innovation in Scholarly Communication and University Engagement" (Lorimer, *et al.*), and "Le livre universitaire numérique: Pour un foyer d'expertise et une infrastructure de stature mondiale" (Boismenu, *et al.*). His latest contribution to exploring new directions in scholarly publishing with an OA orientation is the collection "Parcours numériques" (Presses de l'U de Montréal).

Sinatra currently serves as the Chair of the Research Dissemination Advisory Committee of the Federation. In that capacity, he contributed to the Federation's position statements on cyberinfrastructure and open access, as well as organizing panels at Congress and the annual AGM. Before being elected vice-president (French) of CSDH/SCHN, and then President (French) for two terms, Sinatra was the treasurer of the Canadian Comparative Literature Association, and then the secretary-treasurer of the Canadian Association of Learned Journals. He also served on the board of the Federation as representative of small associations in 2010-2 (during which time he was involved in the sub-committee on site selection for Congress 2015).

Sinatra was chair of the Partners Committee of the SSHRC-funded MRCI project *Implementing New Knowledge Environments*. He served as a member of the executive committee of the Alliance of Digital Humanities Organisations (ADHO), and CenterNet: An International Network of Digital Humanities Centers, and he was also an elected member of the Modern Language Association (MLA) Committee on





Information Technology. He was a founding member of the executive committee of the North American Victorian Studies Association (NAVSA), and was elected to the advisory board of the North American Society for the Study of Romanticism (NASSR). Sinatra also served as Chair of two SSHRC granting programs: "Image, Text, Sound, and Technology", and "Research Development Initiatives". In addition to the national and international roles listed above, Sinatra is a former University of British Columbia Summer Scholar in Residence. Sinatra is also fluent in both English and French.

#### **Treasurer's Report**

#### Review of 2014 results

The Federation ended the fiscal year with a surplus before unrealized gains and losses of \$347,286. This surplus allows the Federation to replenish its Operating Fund to the level experienced in 2008 just prior to several years of significant losses. A significant effort by the secretariat has been under taken in the last three years to return the Federation to a strong and sustainable financial health.

The change in revenue between 2013 and 2014 is mainly the result of the difference in number of months in each operating periods (see note 1 below). Investment income gains, which are budgeted at zero as a conservative risk management practice, were significant as a result of a steady market and exchange gains on the Canadian dollar. Better than expected attendance at Congress at Brock University and increased sponsorships and partnerships further contributed to the 2014 financial success.

Expenses increased in the areas of staffing and meetings as the Federation added resources and partnerships for achieving the objectives outlined in the 2011-15 strategic framework. Notably, the Federation launched the first stages of the Open Access and Impact Projects: nonetheless 2014 expenditures were less than anticipated. Reduced capital spending and the non use of the annual contingency budget (3% of operations) round out the gains in the year.

It should be noted that many of these gains are one-time events. The outcome of a congress, the fluctuation of the marketplace for our investments and the timing of projects vary from year to year. As such, the Federation therefore budgets on both an annual and a 5 year cycle to properly and effectively reflect the continuity of operations and to adhere to a relatively low risk management profile.

The Board of Directors met with representatives of the audit firm Deloitte LLP on April 22, 2015. At that meeting the Financial Statements were reviewed with the auditors as well as a discussion regarding the audit procedures and results. The auditors also conducted an in camera session with the Board and have issued Financial Statements with an unqualified opinion.

#### Technical notes to the Financial Statement Review:

The 2014 Financial statements are impacted by 2 accounting changes that were implemented in 2013.

- 1. In 2013 the Federation changed its fiscal year end to December 31st. This resulted in the 2013 statements representing 15 months of operations. The 2014 Statements represent 12 months of operations. It is therefore difficult to compare the two years of results as they represent different operating timeframes.
- 2. In 2013 the Federation adopted mandatory changes to the Accounting Framework as prescribed by the CICA governing body. The Framework now requires that any Unrealized Gain/Losses are recognizes on the Income statement as either a revenue or expense. It must be carefully noted that this figure only represents the growth or loss in an investment portfolio and not actual cash



flow or loss. Investments would have to be sold to be able to access this 'gain'. This figure can fluctuate over the course of a year and it would be inappropriate to budget for this or operate as though this amount was available to offset operational activities. As a result the line called, *"Excess of revenue over expenses before unrealized gains and losses"* is the line management focuses on in terms of results for the Federation.



# Policy Work

Policy, research and outreach are Federation priorities. We work on behalf of our 160 members to promote the value of research and learning in the humanities and social sciences with decision-makers and influencers.

# **Federal Budget**

Each year, we make federal budget recommendations to the House of Commons Finance Committee. We discuss these with ministers, members of Parliament from all parties, and senior officials to advocate for core priorities, including funding for the humanities and social sciences.

We celebrate that Budget 2014 included our recommendation to make Mitacs internships available to the not-for-profit sector as well as to industry. There was also increased funding for the granting councils and the creation of the new \$1.5 billion Canada First Research Excellence Fund. We will monitor the fund's implementation, and have called for it to support outstanding research across all fields of knowledge to find people-centred solutions to society's most pressing challenges.

# Outreach

We maintain a high profile in the media on key policy issues that are relevant to our scholarly community. We have successfully placed articles, op-eds and letters in mainstream and specialised media in English and French on issues ranging from student mobility to gender equality and the changing nature of academic professional life.

Federation Board members and staff are active in policy discussions and events with members of Parliament as well as senators, senior decision-makers, and diverse policy stakeholders. We also made contributions by presenting and participating at a number of conferences and policy events across the country.

# **Open Access**

The Federation increased the scope of its work and thinking on Open Access given the significant changes underway in knowledge creation and knowledge transmission in a digital world. We commissioned an environmental scan of this rapidly evolving policy terrain and launched a draft policy on *Open Access and the Awards to Scholarly Publications Program (ASPP)*, at Congress 2014. The policy underwent significant consultation with diverse stakeholders and a final version was developed and submitted to the Board, with a view to launch in 2015. The project has provided important leadership in the discussion and promotion of Open Access with regards to the publication of scholarly books in Canada, widening the issue from one that had been more narrowly focussed on Open Access and journals.

# **Research Impact**

In 2014, we released a major working paper that lays out a conceptual framework for capturing the diverse impacts and contributions of social sciences and humanities research to society. The paper, entitled *The Impacts of Humanities and Social Science Research*, provides details on the tools academics, decision-makers and the public can use to measure the impacts of this research—on scholarship, teaching, the economy, communities and policy. The paper is a living document and will be updated as our collective work on impact measurement grows. The project has already attracted national and international attention following its launch in the fall of 2014 at the Entretiens Jacques Cartier in Montréal and at the American Council of Learned Societies. Feedback and interest have been growing steadily thanks to presentations to a SSHRC Leaders meeting and to the Association pour la recherche au collégial.

# Awards to Scholarly Publications Program

The Awards to Scholarly Publications Program (ASPP) enjoyed a successful 2014. Once again, an ASPP-funded book was recognized by the Governor General's Literary Awards: Peter Feldstein won for his English translation of *Paul-Émile Borduas: A Critical Biography* by François-Marc Gagnon, published by McGill–Queen's University Press. The painting *Composition 44* on the cover of this Annual Report, is featured in this book.

A workshop at the Salon du livre de Montréal engaged French-language publishers, authors and translators. In 2015, the Federation will host a professional development webinar on the ASPP for members of the Association nationale des éditeurs du livre.

The ASPP is the Federation's competitive funding program that supports the publication and translation of the best Canadian scholarly books in the humanities and social sciences. Each year, the Federation provides 180 Publication Grants of \$8,000 and five Translation Grants of \$12,000, contributing a total of \$1.5 million annually to the dissemination of Canadian research. Funding for the ASPP, the longest running program at the Federation, is provided by SSHRC.

Looking ahead, the Federation will contribute to the evolution of Open Access in Canada through the ASPP and its policy to support scholarly books.





# Summary of 2014 Financial Report

The Federation continued to focus on effective program delivery in 2014, ending the year in a strong financial position and forecasting a balanced budget for 2014.

Congress 2014 at Brock University was a great success, our revenue stream (from SSHRC and members) remained stable from 2013. The Federation's investment income grew this year, due to growth in financial markets. Investment holdings are of the highest quality, to mitigate the Federation's market risk.

Cost control efforts over the past few years have allowed the Federation to reset baseline spending, resulting in below-budget expenditure results.
